


Making Connections

Attaching the Notebook


1. Turn the Notebook over so the bottom side is facing up.



2. It is recommended to apply the double-sided tape to the bottom of the Notebook in the designated area.




3. Turn over the Notebook and attach it within the four corner frame of the Digital Writing Pad.



Connecting the Digital Writing Pad

- 1. With the USB Cable, connect the Micro USB end to the Digital Writing Pad.
- 2. Connect the USB Type A end to the computer.



NOTE: Do not write on the Digital Writing Pad without the Notebook, this will leave ink marks and affect the surface.

Driver Installation, Use, and Removal

Installing the Driver

It is not necessary to download any drivers or software to use the Digital Writing Pad. However, if you would like more features such as pen pressure, please download and install our **ViewSonic Pen Manager**.

To download and install:


- **1.** Uninstall and remove any drivers of other graphic tablets/monitors installed on your computer.
- **2.** Disable any anti-virus software and firewall temporarily, and ensure you are installing the driver as an Administrator.
- 3. Download and install the driver from: https://pendisplay.viewsonic.com
- **4.** After a successful installation, please restart the computer then plug in the Digital Writing Pad.
- 5. The System Tray will now show the "ViewSonic Pen Manager" icon.



Using the Driver

Pen

Adjust settings related to the pen and how it functions.




• Adjust the *Tip Feel* of the pen - *Soft* to *Firm*.

NOTE: *Tip Feel* alters how much actual pressure it takes to achieve maximum pressure.

- *Soft* requires less actual pressure to see a difference in pen pressure levels.
- Firm more force is needed to see changes in pen pressure.
- Test the *Pressure Sensitivity*.

Mapping

Adjust the screen settings for the handwriting screen.



- Choose the preferred screen *Orientation*.
- Select the Pen Display screen.

Uninstalling the Driver

For Windows

There are two ways to uninstall the driver:

• Start > ViewSonic > ViewSonic Pen Manager > Right Mouse Click > Uninstall

or

• Open the Control Panel > Programs > Programs and Features > ViewSonic Pen Manager > select Uninstall/Change

For Mac

• Open Finder > Apps > Tablet Utility > Uninstall-Driver





Troubleshooting

This section describes some common problems that you may experience when using the monitor.

Problem or Issue	Possible Solutions
The pen is not working	 Try using the computer's mouse; if the mouse also does not work please restart the computer. Reinstall the pen driver (if applicable).
The pen tip is too short, or not making proper contact with the display	 Check the condition of the pen tip. If it is too short, please replace the pen tip.
The cursor is not moving correctly	 Try restarting the computer. Ensure the USB cable is connected properly at both ends.
The pen ink has run out	 Genuine D1 refill cartridges for PF0730-I0WW can be purchased through your local ViewSonic Customer Service.

FAQ

Question	Possible Solutions
How to find out whether the driver was installed properly?	 After the driver was properly installed, and when the tablet and computer are connected properly, a small driver icon will appear in the icon tray of the computer. When the electromagnetic pen is used on the tablet, it will be able to control the cursor properly, and it will be able to sense pressure during the pressure test in the driver control panel.
What should I do if the small digital control panel icon did not appear in the icon tray of the computer after driver installation was completed?	 If the driver was installed for the first time, the computer must be restarted after installation to let the driver complete the initial installation. Make sure that the tablet is connected properly to the USB interface of the computer (it is recommended to connect to the USB interface at the back of the computer) and has not become loose. If it was confirmed that the tablet was connected to the USB interface of the computer but there was still no small driver icon, please try to connect to other USB interfaces and restart the computer.
The tablet cannot be used properly, how do I determine whether the malfunction is a hardware or software issue?	 Connect the tablet with another computer to test it; if the tablet and the electromagnetic pen can be used on the other computer like a mouse without installing the driver, it means that the malfunction was caused by the current computer.
How does the tablet realize drawing creations?	 The tablet is only a type of input device for computers; it is considered hardware, and not drawing software. If you want to perform drawing creations, it must be used with corresponding drawing software to realize drawing creations. It is recommended you purchase or download related drawing software.

- Never spray or pour any liquid directly onto the device.
- Handle the device with care.

Cleaning the Device

- Use a soft, dry cloth.
- Wipe the device with a clean, soft, lint-free cloth. This removes dust and other particles.




Replacing the Pen Tip

Just like a ballpoint pen, the Ink Pen is for writing on the Notebook. When the pen tip runs out of ink or becomes damaged, it can be replaced with spare tips. To replace a pen tip:

1. Use the *nib removal tool* to pull the old tip straight out of the pen.



2. Insert a new pen tip into the pen and push the tip in until it stops and is held firm.
